Requirements for securing Entry Visa To the State of Eritrea

Applications for Entry Visa to Eritrea will be processed when the following requirements are met. Applicants are kindly requested to strictly observe these requirements for speedy processing of application.

1. Submission of:

- 1.1 Passport of applicant (*with a validity of at least 6 months after the date of request*).
- 1.2 A carefully completed Visa Application Form (*The Form can be downloaded from this Website: www.eritreambindia.com*)
- 1.3 Two recent passport – size photographs (*scanned photographs are not accepted*)
- 1.4 An official letter of invitation from a sponsor in Eritrea or a letter of guarantee to support request for a non tourist Visa.

2. The Visa Fees which will be collected by the Eritrean Embassy in New Delhi are as follows:

- 2.1 Rs. 1410 for Tourist Visa. {Single Entry}
- 2.2 Rs. 3055 for Business Visa {Single Entry}
- 2.3 Rs. 2585 for Employment Visa {Single Entry}
(*This requires supporting documents from the Labour Office and the Employer in Eritrea.*)
- 2.4 Rs. 3760 for Multiple Entry Visa {Three Months}
(*Not provided to Tourists*)
- 2.5 Rs. 5640 for Multiple Entry Visa {Six Months}
(*Not provided to Tourists*)
- 2.6 Rs. 9400 for Multiple Entry Visa {Twelve Months}
(*Not provided to Tourists*)
- 2.7 Rs. 940 for Transit Visas.

3. An additional:

Rs. 235 Postal Charges will be collected for those applying via mail within India.

4. Those who want their Visa to be issued within 5 working days are obliged to pay an extra amount of:
 - Rs. 235 for Tourist Visa
 - Rs. 470 for Business Visa
 - Rs. 470 for Employment Visa
 - Rs. 705 for Multiple Entry Visa {Three Months}
 - Rs. 1175 for Multiple Entry Visa {Six Months}
 - Rs. 1880 for Multiple Entry Visa {Twelve Months}
 - Rs. 235 for Transit Visa
5. Applicants outside of India, Indonesia, Thailand, and Singapore should contact the nearest Embassy of the State of Eritrea.
6. Other consular services available for Eritreans residing in India are the following:
 - Renewal of Passports.
 - Attestation.
 - Confirmation of Power of Attorney.
 - Issuing of ID Cards
 - Issuing of Laissez- Passer
7. An ordinary Entry Visa is valid only for One Month from the date of Entry to Eritrea.
8. Other Details:
 - 8.1 When a request is forwarded via mail, applicants are advised to make their payment in good time. Visas will not be issued until our account officer confirms receipt of the payment.
 - 8.2 For applications lodged in India, the only acceptable method of payment is by a bank draft in Indian Rupees, favouring *The Embassy of Eritrea*, New Delhi.
(*Payment by cheque is not accepted*).
 - 8.3 Please do not deposit more than one draft per application.
 - 8.4 Please note that fees and charges are non refundable, even if applications are withdrawn or refused.
